Scholarships - How the Foundation Helps

Each year graduating Danville High School seniors are provided with various opportunities to apply for scholarships through the Danville High School Guidance Office.

What is not readily known is that the Danville Public School Foundation assisted in establishing thirteen scholarships.

The Foundation does not administer the scholarships, however, it acts as a conduit for the scholarship funds. A donor makes a tax deductible scholarship gift to the Foundation, which the Foundation acknowledges. The Foundation then transfers the funds to the Danville School District 118's Business Office. The District establishes a scholarship account with a local bank. When a student receives a scholarship, the District issues a check directly to the college the student is attending. Annually, the Business Office notifies the donor establishing the scholarship as to who received the scholarship.

Donors establish scholarships for various reasons: to honor a loved one, to recognize a teacher or to honor a career. Ultimately the scholarships are established to help graduates who aspire to expand their education.

The scholarships currently available that the Foundation help facilitate are:

Class of 1966 Science & Math Scholarship - Established in 2020, by Dr. Doug & Mrs. Julie Mathisen to recognize the top student in Math, Chemistry, Physics, or Biology.

Helen Conover Scholarship — Established by Dr. Herbert Smith in honor of Helen Conover, a DHS Latin teacher from 1924-1965.

Mark Denman Scholarship - Established by community members in honor of Mr. Denman's retirement as Superintendent of Danville District 118. Mr. Denman continues the support of this scholarship.

Wayne & Marjorie Denman Scholarship - Established by memorial donations upon the Denman's passing. Mr. Mark Denman continues to support this scholarship.

Dick Van Dyke Scholarship - Established by funds from a 2004 Danville High School Event in honor of Mr. Van Dyke and a gift from Mr. Van Dyke.

Nanette Finkle Scholarship - Established by community members in honor of Mrs. Finkle's retirement as Superintendent of Danville District 118. Mrs. Finkle continues the support of this scholarship.

Julius W. Hegeler II Scholarship -Established in 2019 upon Mr. Hegeler's passing and in honor of his contributions to the Danville Public School Foundation.

John Stevenson Annual Memorial Athletic/Academic College Scholarship - Established and supported by John Stevenson.

Johnathon Wallace Scholarship -Established by Richard and Marcella Wallace, for a Special Education student, in memory of their son Johnathon.

Robert & Sue Seybold Zimmerman Scholarship - Established by Sue Zimmerman after her husband Robert's passing. It supports the studies of a student going into the trades.

The Guidance Office at Danville High School makes the scholar-ship applications available to the students. Scholarships are awarded based on the established scholarship criteria set forth by the donor.
